Phase III: Needs Assessment

- Develop and distribute quantitative needs assessment survey; evaluate program to identify strengths and weaknesses
- Consulted NACA program director and administrative personnel
- Aimed to have 15 parents/caregivers complete the survey
- 35 Likert scale questions
- 4 open-ended questions

Phase III: Needs Assessment

- NAU scholars distributed
- At program pick up time, parents were able to complete/take home survey
- Responses entered into separate data file
- Shared results - Pathways program director and NACA administrators
 - Information can be used to address areas of improvement identified

Summary of Need Assessment Results

N=14 (13 filled in questionnaire)

Overall, highly positive rating of the program!

For every questionnaire question (97% of the questionnaire) the majority of respondents rated agree (4) or strongly agree (5)

For one question, less than 75% of respondents provided rating in the 4-5 range

Behavioral health group- 62% rated 4 or 5

Willing to pay - 43% rated 4 or 5

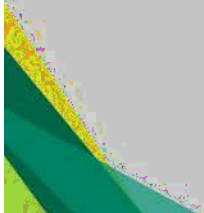

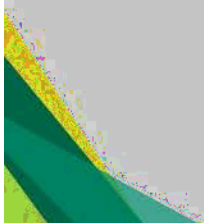

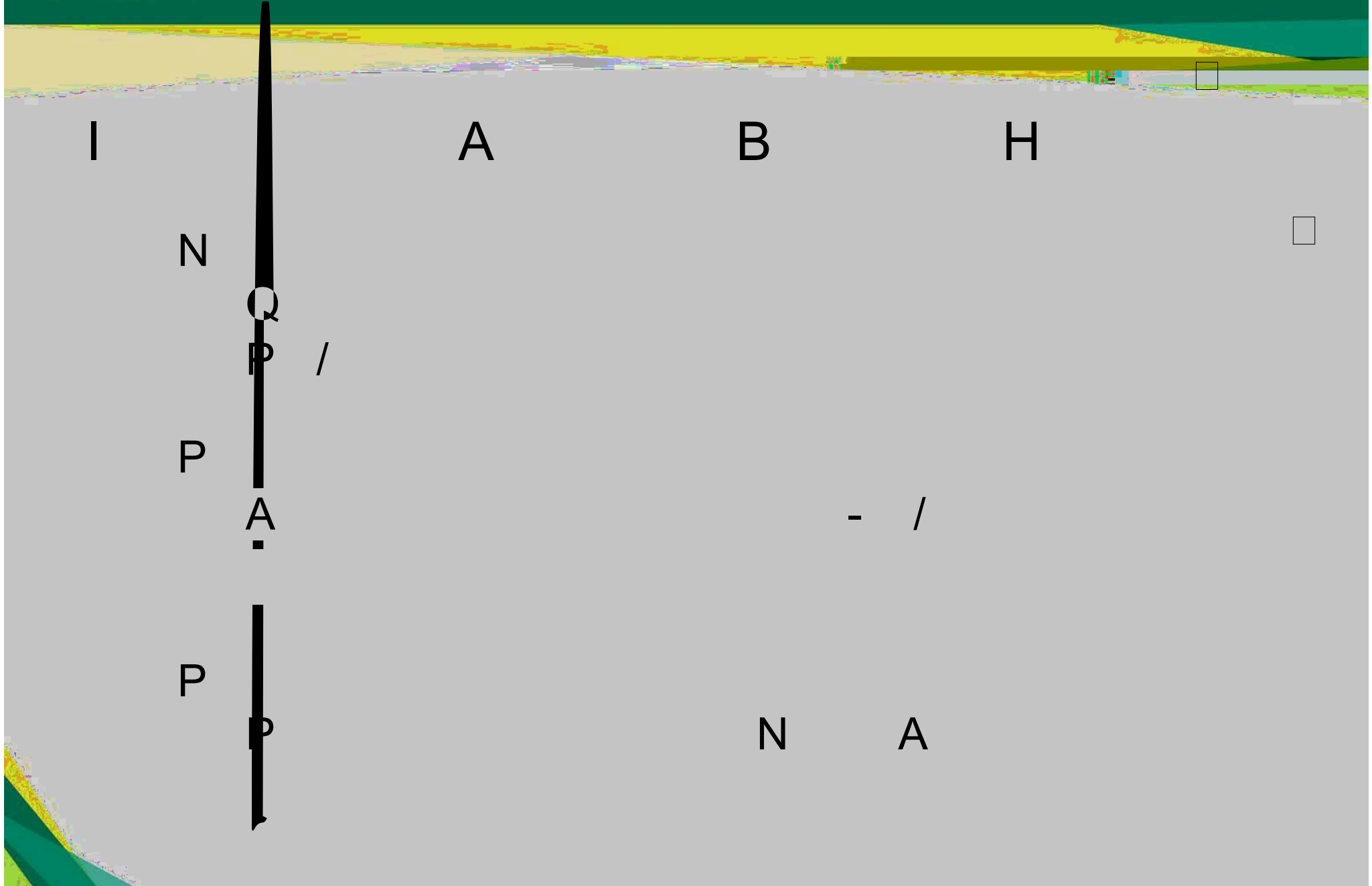
